


# 2022 Annual Report

Safe2Help is a free, non-punitive, effective state-wide school safety program that seeks to prevent bullying, mental health struggles, threats of violence, and anything impacting school safety. It provides a safe confidential environment for students to share information 24 hours a day, 7 days a week.



# A SCHOOL SAFETY INITIATIVE

Safe2Help was a recommendation provided by the Illinois Terrorism Task Force's School Safety Working Group following the Stoneman Douglas High School tragedy in Parkland, Florida.

Due to the collaborative efforts of the School safety Working Group, the Student Confidential Reporting Act (Public Act 102-0752 of 2022) was signed into law in May 2022.

Safe2Help is a collaboration between the Illinois Emergency Management Agency, State Board of Education, Department of Human Services, Department of Children and Family Services, and the Illinois State Police. Public Act 102-0752 of 2022, authorizes the creation, operation, and staffing of a helpline that:

- Operates 24 hours a day, 365 days a year;
- Protects the confidentiality of the reporter's identity; and,
- Safeguards report information from Freedom of Information Act Requests (FOIA).



# The Research

The 2021 United States Secret Service's Averting Targeted School Violence Report:



94% of the plotters shared their intentions about carrying out an attack through verbal statements, electronic messaging, and online posts



In 69% of the cases, communications about an attack plot were observed by friends, classmates, or other peers of the plotter.

# Mission

In the absence of a trusted adult, Safe2Help offers students a safe, confidential way in which to share information that might help prevent suicides, bullying, school violence or other threats to school safety. This program is not intended to suspend, expel, or punish students. Rather, the goal is to get students to "Seek Help Before Harm." Safe2Help has developed an Mental Health Toolkit aimed at changing the culture in Illinois schools while also providing the resources to help parents and educators reinforce the components of this program.

# Goal

The goal of Safe2Help is to end the culture of silence so a student who is struggling can get needed help before a situation turns into a tragedy.

# How to Share Information

### **Submit and Receive**

Students can confidentially send information on anything that impacts their safety or wellbeing.



### **Respond and Report**

Information is shared with school and district officials. Depending on the nature of the information received, 9-1-1 call centers will be contacted to dispatch the appropriate response.

> The information is investigated, and resolved

# Safety is in Your Hands

#### **Success Stories**

Suicidal Ideation- Self Reported. A student contacted Safe2Help with thoughts of depression and was experiencing a relapse and harming themselves again. The student was located and transported to the hospital for evaluation and treatment.

#### **Child Abuse**

A student shared that they were being abused by a parent. The information was shared with school officials and referred to law enforcement and Child and Family Services. The information shared was investigated and substantiated.

Threat of Planned School Attack Safe2Help received information about a concerning social media post. The information was shared with school officials and referred to law enforcement. The student who made the post was disciplined.


### THE DATA

Public interactions for calendar year 2022 INCREASED MORE THAN 137% compared to 2021.




The increase in public interactions is likely attributed to several factors.

- 1. The program launched statewide on October 21, 2021.
- 2. Safe2Help saw a 253% increase in school districts registrations.
- 3. Students were more inclined to share information following school shootings in Uvalde, TX and St. Louis, MO.

#### Dispositions



Schools are asked to share information to let us know how the process worked to evaluate the effectiveness of the response. This is a voluntary process.

As a result of information shared with the helpline, call center technicians or school officials forwarded:

- 110 incidents to law enforcement
- 17 incidents to mental health professionals, school counselors or school psychologists
- 7 incidents to Child and Family Services



#### Definitions

**Critical:** Involve immediate or imminent threat of violence or potential self-harm such as but not limited to, threats of suicide and threats of planned school attack,

**Standard:** May include, but are not limited to; bullying, cyberbullying, vaping, or substance abuse.

**Other:** May include but, are not limited to; false reports, prank reports, requests for

information, or misapplication of system.



#### Safe2Help Website

The Safe2Help website provides self-help resources for students and educators with activities, exercises, and videos to help address what students or their friends may be struggling with.

Student focus groups are utilized to drive topic and content creation. Currently, the Safe2Help website features ten self-help topics and ways students can help a friend. Content is developed by mental health professionals from Boys Town specifically for middle and high school students.

#### **Video Content**

In partnership with the University of Illinois Springfield, Safe2Help has created promotional and topic specific videos for students and educators to reinforce key messages and learnings from website selfhelp topics.

In May 2022 Safe2Help and the University of Springfield were awarded a Silver Telly in the Category of Social Video at the 43rd Annual Telly Awards. The award honors excellence in video and television across all screens and is judged by leaders from video platforms, television, streaming networks, production companies and includes partners like Adobe, Netflix, Dow Jones, A&E Networks, Hearst Media, Nickelodeon, ESPN Films, and Vimeo.

# Safe2Help Training

In 2022, Safe2Help offered free virtual and in-person presentations and trainings to schools and districts upon request. Safe2Help conducted 52 seminars attended by over 253 districts and/or schools.

Safe2Help has invested in statewide marketing efforts through television and radio campaigns to educate parents, community members, and educators on the availability of Safe2HelpIL as a resource.




#### **Student ID Card Act**

With the release of Public Act 102-0416 that goes into effect January 1, 2023, Safe2Help or a local suicide prevention resource number is required to go on the back of any issued student identification cards, student handbooks, and any student planner that is custom printed and distributed for students in grades 6 through 12.

#### Social Emotional Learning (SEL) HUBS

SEL Hubs are providing free professional development, training, and support to districts in their region to establish and expand SEL programs in Illinois schools. They are assisting school-community leadership teams to implement data-driven strategies to address student trauma and mental health needs and build resilient communities.

Each SEL Hub provides training on Safe2Help, the Safe2Help Mental Health Toolkit, Digital Literacy, Youth Mental Health First Aid, and more! Contact to schedule training for your district or school.



Safe2Help is changing attitudes and perceptions about sharing information on behavior and situations that impact school safety and student's overall well-being. For calendar year 2022, there were a total of 817 incidents with critical incidents increasing by 86.4% over 2021.

### DEFINITIONS

**Non-safety concern** – A question, statement, or media file submission that is not a school safety concern.

**Example**: A student is having a difficult time with friends and wants to talk to someone.

**Concerned reporter:** Reporting about suspicious activity, or reporting about a friend/student/staff member someone is worried about. **Example:** A student perceives a friend is upset and do not know how to help them. Concerned about a teacher who is receiving mean comments from students.

**School complaint tips**: Complaints about school or school staff. **Example**: A student does not like to run and is complaining about having to do the activity. A teacher is assigning homework that is difficult. The teacher favors a student over the other.

**False Reports:** Non-actionable reports received with malicious intent. They may include false information to harm, injure, or bully another person.
